Planning Commission Report

At the May 13th Planning Commission, the Town Administrator reported that a permit had been issued to David Kear for framing. He additionally reported that the Town would most likely be hiring a part-time building official who will provide building reports in the future.

A subdivision plat to be reviewed and considered was presented by David Kear, but was denied at this time. Mr. Rockwell, ETDD Planner, will confer with the applicant's engineer on possible solutions. There was a brief discussion, then general consensus not to allow subdivisions off of easements.

In a separate topic, the Commission agreed to keep the present Planning Region.

There was a lengthy discussion regarding regulation of short term rentals, including rental cabins, Airbnb, and Vrbo properties. Mr. Rockwell advised the Commission of the state law that set precedent and guidelines for a permitting process that provided oversight for the Town. He will consult with MTAS regarding how to confirm occupancy, and liability issues.

The Six BearWise Basics

Never Feed or approach Bears

Intentionally feeding bears or allowing them to find anything that smells or tastes like food teaches bears to approach homes and people looking for more. Bears will defend themselves if a person gets too close, so don't risk your safety and theirs!



Food and food odors attract bears, so don't reward them with easily available food, liquids or garbage.



Birdseed and grains have lots of calories, so they're very attractive to bears. Removing feeders is the best way to avoid creating conflicts with bears.



Never Leave Pet Food Outdoors

Feed pets indoors when possible. If you must feed pets outside, feed in single portions and remove food and bowls after feeding. Store pet food where bears can't see or smell it.



Clean & store Grills

Clean grills after each use and make sure that all grease, fat and food particles are removed. Store clean grills and smokers in a secure area that keeps bears out.

STORY, LEGEND OR TRUTH

Remembering Emert's Cove in the 1930's

David Barber first visited Emerts Cove around 1933 when his parents took him and his brother Dean on a camping trip from their home in Knoxville. He was around twelve and caught his first fish in the Middle Prong near where the family's tent was pitched. The Barbers liked the area so much that they



inquired of a local resident, Newt Ogle, about purchasing land. Amos Marshall was willing to sell two acres on the river where the Barber's built a cabin, joining the several Smoky Mountain Hiking Club members who had cabins in the area. David and Dean spent the next few summers working on the cabin but progress was slow because they took frequent breaks to swim and fish with their new friends in the neighborhood. The Ramsey children asked them to swim several times a day; David later learned the reason for such popularity was that the Ramsey parents would not let the children swim unless the older Barber boys came along. They enjoyed swimming at the Corner Hole and Flint Rock, where David met the 'much younger' Dolly Parton and her parents.

Greenbrier Island was the local ball field, where adult teams from Gatlinburg, Pittman Center, Cosby and the surrounding area played baseball while the fans spread picnics and visited. The boys fished up and down the river and sometimes found

moonshine in glass jars which they dumped out and refilled with river water as a prank. Squirrel hunting was a regular pass time, and when David enlisted in the Marine Corps he impressed the officers by hitting the bullseye while other recruits were missing the entire target. He went on to serve in the Solomon Islands during World War II, attended the University of Tennessee on the GI Bill and enjoyed a career coaching football in Florida. He returned to Sevier County in 1979 for an encore career in local law enforcement for twelve years. At age 98 David continues to serve his community as a volunteer at Leconte Medical Center, where he spends most weekdays at the Information Desk. Stop by and say 'Hi'!
