g. Reading and Consideration of Resolution No. 222: A Resolution of the Town of Pittman Center to Revise the Personnel Policy


Judy Tucker made a motion to approve Resolution No. 222. Rachel Huskey seconded the motion. All Ayes. Motion Passed.
