TOWN MEETING ANNOUNCEMENTS

All Town meetings are open to the public. Members of the community are encouraged to attend! Complete minutes (after they are approved by the BMA) are available on the Pittman Center web site. Below is an *unofficial* and brief overview of the meetings.

Planning Commission

During the regularly scheduled meeting held on February 10th the Planning Commission:

1. Reviewed and Discussed Overnight Rentals: The Planning Commission reviewed a Zoning Ordinance Amendment that would limit the size of overnight rentals in certain zoning districts.

- 2. Reviewed and Discussed Dark Skies Resolution: The Planning Commission reviewed a Resolution to encourage Sevier County Electric System to adopt the standards of ANSI/IES RP-8 and the International Dark Skies Association's model lighting Ordinance regarding obtrusive lighting for its street lights. The Planning Commission recommended the Ordinance to the BMA for approval.
- 3. Reviewed and Discussed Building Height Regulations.

Board of Mayor and Aldermen (BMA)

During the meeting held on February 20th the BMA:

- 1. Passed on second reading Ordinance No. 291: An Ordinance of the Town of Pittman Center, Tennessee to replace Ordinance No. 217 in its entirety and replace with a new Tree Ordinance.
- 2. Passed on second reading Ordinance No. 292: An Ordinance of the Town of Pittman Center, Tennessee to adopt a Tourist Residency Program.
- 3. Passed on second reading Ordinance No. 293: An Ordinance of the Town of Pittman Center, Tennessee Amending Title 12 of the Municipal Code to Designate the Building Official as a Special Police Officer for Issuing Citations in Lieu of Arrest.
- 4. Passed on second reading Ordinance No. 294: An Ordinance of the Town of Pittman Center, Tennessee, Replacing Municipal Code §15-8 and Adopting by Reference State Traffic Offenses and Rules of the Road.
- 5. Passed on second reading Ordinance No. 295: An Ordinance of the Town of Pittman Center, Tennessee to amend the FY20 Budget.
- 6. Passed Resolution No. 223: A Resolution of Pittman Center, TN Encouraging Sevier County Electric System to Adopt the Standards of ANSI/IES RP-8 and the International Dark Skies Association's Model Lighting Ordinance Regarding Obtrusive Lighting for its Street Lights.

BMA Notes:

- Please note that the Tourist Residency program will only affect <u>new</u> overnight rental units and units that currently do not comply with rules, regulations, fail to remit hotel/motel taxes, or otherwise not meet the requirements to be considered grandfathered in Tennessee Code Annotated.
- The ability for the Building Official to issue citations is limited to building codes, property maintenance, planning and zoning, etc., and does <u>not</u> include criminal, traffic, or other Police Department related offenses.

The Board of Mayor and Aldermen will meet on Thursday March 19th at 4:30

The next Tree Board meeting is yet to be determined.

The next Recreation Board meeting is yet to be determined.

injuries and damage to public infrastructure was limited to Old Hills Creek Road and Butler Branch Bridge. The Town also

experienced severe flooding on Webbs Creek Road which was closed down by the Town's Maintenance Department. If you see road closed signs and barricades for your safety please do not drive through or




around the signs and barricades. The Town will only close roads for public safety. The washout on Old Hills Creek Road has been repaired by the Town's Maintenance Department. The Town is working with engineers to ensure that



Butler Branch Bridge is repaired appropriately. We will have more updates in the future as that project progresses. We have no further updates on infrastructure projects at this time.

The Town of Pittman Center & AirMedCare

Daniel Willis from AirMedCare will be at Pittman Center City

on *Thursday March 12th from 12p.m. to 5 p.m. and Friday March 13th from 6:30 a.m. to 11 a.m.* for citizens wishing to upgrade their membership.

Remember the Town partners with AirMedCare to provide basic coverage which means:

Any individual whom resides within the boundaries of The Town of Pittman Center, TN when transported for medical necessity by Lifestar (or any AirMedCare Network Provider) will be covered under the standard terms and conditions for an AirMedCare Network membership except:

- Transport must be from a pickup location in Sevier County, TN;
- If covered person transported is uninsured (or has no billable insurance) at the time of transport, Med-Trans Corporation will bill the covered person at the "Medicare Allowable Rate" for the transport.

While this is a great service, you can upgrade your benefits to a full membership with additional coverage. By upgrading to a full membership, this removes the two limitations mentioned above. A full membership includes coverage in an additional 38 states with 320 locations for an additional \$45.00 per year per household you can cover everyone living under your roof. If anyone in the home is 60 years of age or older then the whole home is an additional \$35.00 per year.

Due to the agreement with the Town of Pittman Center being annual the discounted rates are only available on a yearly basis. AirMedCare will mail you a letter within 90 days of your full membership's expiration date. If you have any questions regarding renewals please contact Daniel at Daniel.Willis@airmedcarenetwork.com


REMINDERS...
