- c. **Reading and Consideration of Resolution No. 241: Authorizing the Town of Pittman Center to Transfer TDEC ARP Funds to Sevier County**


The Motion to Approve Resolution No. 241 was made by Steve McCarter and Seconded by Kevin Howard. With All Ayes, Motion Approved.
