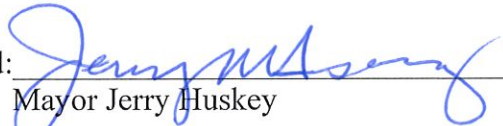
- c. **Public Hearing and Second Reading of Ordinance No. 340: An Ordinance to Amend Title 3, Chapter 2, Section 3-202 to Establish Reasonable Court Costs**

The public hearing was open and with no comments, it was closed at 5:24 p.m. A motion was made by Billy McCarty to approve Ordinance No. 340 with an amendment in Section 1. Title 3, Chapter 2, Section 3-202, paragraph 3. Reflecting the increase of proposed amount of \$25.00 to \$30.00 for the separate court cost for items that would be dismissed if the person charged with the violation can provide evidence before court that the item is now corrected. A second was made by Steve McCarter. With all ayes, the motion passed.

- a. Billy McCarty presented the possible interest from the school to build a new playground for the Pittman Center Elementary School on the property across from the Greenbrier Campground. The playground would belong to the school. No action taken.
