## CALL TO ORDER AND APPROVAL OF MINUTES

REVIEW AND CONSIDERATION OF REZONING THREE LOTS FROM RLD TO C-2 FOR PROPERTY LOCATED ON EAST PARKWAY, GATLINBURG, TN M:109 P:32.00, 32.01 & 33.00.

Chairman Defoe made a motion to recommend to the Board of Mayor and Aldermen rezoning with concerns about the undeveloped condition of Tunis Road. Mayor Huskey seconded the motion. The motion carried unanimously.

REVIEW AND CONSIDERATION OF ORDINANCE No. 341 AN ORDINANCE AMENDING SECTION 11-410 OF THE ZONING ORDINANCE OF THE TOWN OF PITTMAN CENTER, TENNESSEE FOR PROVISIONS FOR ILLUMINATED OPEN SIGNS WITHIN THE TOWN OF PITTMAN CENTER.

Chairman Defoe made a motion to recommend Ordinance 341 to the Board of Mayor and Aldermen for approval with the revisions for 6a to read: One (1) non-flashing self-illuminated "Open" window, and/or one (1) non-self-illuminated wall sign, or a non-self-illuminated sign attached to a freestanding sign not to exceed two (2) square feet in area is permitted, in accordance with all applicable sign regulations, which was seconded by Dan Reilly. The motion carried unanimously.
